

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to Facebook Meta Business, and FLYEBIKE INC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to FLYEBIKE INC include <https://flyebike.com>. The FLYEBIKE INC application is a E-Commerce application. By using the FLYEBIKE INC application, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, FLYEBIKE INC may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase FLYEBIKE INC's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. We also may gather additional personal or non-personal information in the future.

Use of your Personal Information

FLYEBIKE INC collects and uses your personal information to operate and deliver the services you have requested.

FLYEBIKE INC may also use your personally identifiable information to inform you of other products or services available from FLYEBIKE INC and its affiliates.

Sharing Information with Third Parties

FLYEBIKE INC does not sell, rent or lease its customer lists to third parties.

FLYEBIKE INC may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is not transferred to the third party. FLYEBIKE INC may share data with trusted partners to help perform statistical analysis,

send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to FLYEBIKE INC, and they are required to maintain the confidentiality of your information.

FLYEBIKE INC may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on FLYEBIKE INC or the site; (b) protect and defend the rights or property of FLYEBIKE INC; and/or (c) act under exigent circumstances to protect the personal safety of users of FLYEBIKE INC, or the public.

Right to Deletion

Subject to certain exceptions set out below, on receipt of a verifiable request from you, we will:

- Delete your personal information from our records; and
- Direct any service providers to delete your personal information from their records.

Please note that we may not be able to comply with requests to delete your personal information if it is necessary to:

- Complete the transaction for which the personal information was collected, fulfill the terms of a written warranty or product recall conducted in accordance with federal law, provide a good or service requested by you, or reasonably anticipated within the context of our ongoing business relationship with you, or otherwise perform a contract between you and us;
- Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity; or prosecute those responsible for that activity;
- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.

Children Under Thirteen

FLYEBIKE INC does not knowingly collect personally identifiable information from children under the age of thirteen. If you are under the age of thirteen, you must ask your parent or guardian for permission to use this application.

E-mail Communications

From time to time, FLYEBIKE INC may contact you via email for the purpose of providing announcements, promotional offers, alerts, confirmations, surveys, and/or other general communication. In order to improve our Services, we may receive a notification when you open an email from FLYEBIKE INC or click on a link therein.

If you would like to stop receiving marketing or promotional communications via email from FLYEBIKE INC, you may opt out of such communications by Replying STOP or Clicking on the "UNSUBSCRIBE BUTTON".

External Data Storage Sites

We may store your data on servers provided by third party hosting vendors with whom we have contracted.

Changes to this Statement

FLYEBIKE INC reserves the right to change this Privacy Policy from time to time. We will notify you about significant changes in the way we treat personal information by sending a notice to the primary email address specified in your account, by placing a prominent notice on our application, and/or by updating any privacy information. Your continued use of the application and/or Services available after such modifications will constitute your: (a) acknowledgment of the modified Privacy Policy; and (b) agreement to abide and be bound by that Policy.
